Determine the amount of product required, using the calculations and the following charts.

**Start-up Applications:** Apply specified dose every 14 days until desired level of muck reduction is achieved.

**Maintenance Applications:** Apply specified application rate every 30 days to maintain desired appearance and digest muck seasonally.
