Wear proper safety equipment including rubber gloves and eye protection when handling or applying this product.

- Determine amount of product required using the table below.
  Calculate Acre-feet using: length x width x depth / 43,560
- Multiply Acre-feet by rate shown in table to find amount of product required in gallons.
- Make a solution with 1 part product to 9 parts water.
- Disperse evenly with clean sprayer or other appropriate method.
- Apply maintenance amount two weeks after initial application and then every two weeks following throughout season.

Always make a solution prior to application and use the solution the same day. Disperse evenly. Do not exceed maximum application rate. Failure to make a solution and disperse evenly or exceeding application rate may cause fish mortality. When mixing with aquatic dyes, use mix on same day – this product will not interfere with dyes applied prior to or after application.

STORAGE AND DISPOSAL: Keep this product dry in its tightly closed container when not in use. Store in a cool, dry, well-ventilated area. Keep from freezing. Use within 24 months. Do not reuse empty container. Rinse empty container thoroughly with water, then offer for recycling, or dispose in accordance with state and local regulations. In case of spill, wash down with water and flush into sewer system.
