### **DIRECTIONS FOR USE**

For application to ponds and ornamental bodies of water.

**IMPORTANT:** Do not apply this product to water intended for direct human consumption. Do not use this product in streams, rivers or other bodies of water which are not under the control of the user. Only use this product in accordance with local, state and federal regulations.

#### **USE RATE**

Apply at a rate of 16 oz per 1 acre foot of water. More or less SePRO Blue can be applied to attain the desired look. Pour correct dosage of SePRO Blue dye directly into the water at several different locations to improve the dispersion rate. To determine the "Acre-Feet" volume, multiply the surface acres of the pond by the average depth.
